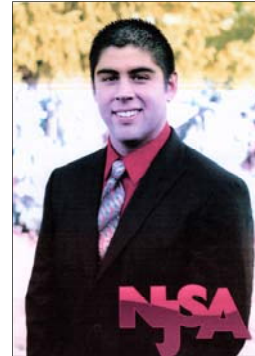

He began his college education at Modesto Junior College and then transferred to California State University, Chico. Corey is currently majoring in Animal Science and minoring in Agriculture Science. He is working toward earning a PhD in Animal Science with an emphasis in Ruminant and Monogastric Nutrition. Upon completion of his studies Corey plans to be a University Professor.

Corey has been involved in several clubs and organizations during his college years. While at CSU, Chico he has become involved in the Young Cattlemen's Association, Tehama County Cattlemen's, California Cattlemen's Association and the California Farm Bureau. He has volunteered his time as a speaker and demonstrator for Nasco Company Livestock Fitting, Showing & Husbandry classes and the Tehama District Fair Livestock Show & Auction.

Corey wrote in his essay about the "disconnect between the producer and the consumer" and his concern that the general public does not understand "how their food gets from the field to the fork". ### *Lee Hofman - \$1,500*

Lee graduated from Corning High School in 2010. He has lived in Tehama County for four years. Lee is a sophomore at Oregon State University. He is majoring in Animal Science and minoring in Agriculture Science. Upon the completion of his Bachelor's degree, Lee plans to become an owner/operator of a cow and calf operation.

Lee has been involved in several clubs and organizations during his college years. While at Oregon State University he has been the President of the Young Cattlemen's Association, Vice-President in Collegiate FFA, and a member of the Dairy Club. He has also volunteered his time with the Ag In The Classroom program and helped implement the Oregon State FFA Convention.

Lee wrote in his essay about the struggle of maintaining "fertile [agriculture] land, while still in strong production", and the rural growth and development that California and Tehama County continues to see. Lee expressed that he understands why families wish to live in such a beautiful area, and as farmers and ranchers we need to continue to educate the public on the need to keep fertile land in production.

James Males, a Professor at Oregon State University, submitted a letter of recommendation on Lee's behalf. Mr. Males states that, "Lee is a leader. It is impressive that the Young Cattlemen's Club elected him as a first year student to be their President. I've been impressed by Lee's organization in preparing for the meetings and his leadership of the meetings. He has already firmly established himself as a leader among his fellow students...".



### *Jadda Miller - \$1,500*

Jadda graduated from Red Bluff High School in 2007. She has lived in Tehama County her whole life. She has completed her studies at Shasta College and will be attending the University of California, Davis in the fall of this year. She will be majoring in Sustainable Agriculture. Jadda plans to earn her Master's degree. Her goal is to one day become a policy maker for the USDA. She would also like to become a restaurant owner.

Jadda has been actively involved with various clubs while

she has been in college including: University and Colleges Fight World Hunger; Amnesty International and Human Trafficking Awareness. She has also been a volunteer with Healthy Shasta's Chef at the Market, St. Elizabeth patient services and the Good News Rescue Mission.

In her essay, Jadda wrote about her concerns of a disconnect between the local farmer and rancher to the community and schools. Jadda stated, "We need to get our children thinking about where their food actually comes from, which doesn't consist of a box, wrapper, or plastic bag, but from the soil of our earth."

A letter of recommendation was received on Jadda's behalf from Leimone Waite, a Horticulture Instructor at Shasta College. The letter states, "Jadda has shared with me her excitement and a vision towards developing a community that is both sustainable and supported by local agriculture. She is already working with local growers, local restaurants and Edible Shasta-Butte to promote our local food system both by teaching cooking classes and writing articles...I know she will be successful in her future educational and career plans."



### *Adam Andreini - \$1,500*

Adam is a 2008 graduate of Red Bluff High School. He has also lived in Tehama County his whole life. Adam began his college education at Questa Community College. After realizing that he belonged in Northern California, he transferred to Butte College and will be attending California State University, Chico in the fall. He is majoring in Crop Science with a minor in Agriculture Business. After earning his degree, Adam plans to pursue a career as a Pest Control Advisor and a Certified Crop Advisor.

Adam has been involved with the Horticulture Club, Bass Fishing Club, and the Agriculture Ambassadors Club while in college. He has also volunteered his time with Frugal House Clean Up for the North State Symphony.

In his essay, Adam wrote about the promising future of agriculture in Tehama County. He states that "farmers are investing in crops that are going to take several years to mature and start producing yields...Because agriculture is thriving, there are also more job positions available, which is why I am very happy to be involved in the industry."

A letter of recommendation was received on Adam's behalf from Bruce Hicks, an Agriculture Instructor at Butte College. In Mr. Hicks letter he states, "He [Adam] has impressed me with his outstanding academic performance, civic engagement, and his determination to succeed." An additional letter was received from Mike Landini, owner/operator of Divide Ranch Grass-Fed Beef. Mr. Landini states, "He [Adam] is motivated and has worked very hard to continue to attend college while building his own yard care business and hunting guide operation... He has a deep understanding, respect and appreciation of what agriculture means to Northern California."



### Bailey Miller - \$1,000

Bailey is another Red Bluff High School graduate. She graduated in 2009 and has lived in Tehama County her whole life. She is a student at California State University, Chico where she is majoring in Agriculture Business with a minor in Animal Science.

Throughout her college years, Bailey has been involved in several clubs and organizations including the Young Cattle-men's Association, Tehama County Farm Bureau, and the California Cattlemen's Association. She has also volunteered her time with the Ide Adobe State Park Docent Program and the Tehama District Fair

In her essay, Bailey wrote that the promising future of agriculture in Tehama County will be strong because of the continued education between farmer and non-farmer groups. She sees the huge importance of events and social activities that educate consumers about the commodities in Tehama County and California. She states, "The future of Tehama County is in its youth..." knowledge must be passed on to the "younger generation and hope that they too will aspire to being a part of the agriculture community."

Kari Dodd, the Manager of the Tehama Farm Bureau wrote a letter of recommendation in which she states, "She [Bailey] has shown her passion for agriculture through the many roles she has held in Tehama County." According to Treasurer, Mary Christensen, the Dairyville Community Club, Inc. has been sent a total of ten payments since May of 2010, and the total amount received is **\$2,186.91**.

*The way the program works is: The company that owns Save Mart, S-Mart, Food Maxx and Lucky supermarkets gives a 3% donation to the Community Club for every dollar that is spent at one of their grocery stores. Cardholders simply ask the cashier to swipe their S.H.A.R.E.S. card before they pay for their groceries and the DCC receives credits.*
